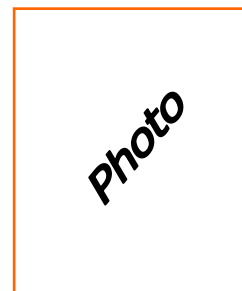

## FMAJI COMPETITION RULES

the FMAJI bureau, upon suggestion from their artistic director, chooses the jury as so:

### 8 members:

1 président of the jury

4 music specialists, 2 for each discipline

the artistic director

2 members of the board ( 1 must be a professional musician)

### **how to apply:**

All applicants must submit:

- 1) the application form with photo
- 2) Birth certificate or any official document establishing the age of the applicant
- 3) Biography (or curriculum vitae) which should include details of musical activity
- 4) Parental authorization for participation in the international competition of the Musical Festival of Autumn Young Interpreters (FMAJI)
- 5) Form of renunciation of the right to the image signed by the applicant or its legal representative
- 6) A performance video of at least 10 MINUTES of the candidate to be uploaded or a link to a accessible streaming platform. On the video, at least two extracts of any pieces of the candidate choice.
- 7) Registration fee: a non-refundable fee of 20€ on the bank account of the competition and a non-refundable fee of 60€ in case of selection for the first round

The application forms will be examined by the Artistic Director who will then propose to the Board the list of applicants admitted to the First Round.

Confirmation of receipt of the online application is immediate.

All applications received after the deadline will not be admitted.

Notification of acceptance or non-acceptance to the Competition will be sent to the applicants by email.

## **General rules**

### **Pre-selection on video link**

A performance video of at least 10 MINUTES of the candidate to be uploaded or a link to a accessible streaming platform. On the video, at least two extracts of any pieces of the candidate choice.

### **First Round**

**Article 1 :** The members of the jury vote by secret ballot and, by a majority, designate the candidates able to stand for the final round. In case of a tie, the President of the Jury has a casting vote.

**Art.2** At the end of the deliberation, the selected candidates will be called for the final round and the order of passage will be established by lot by the finalists themselves.

### **Final Round**

**Art.3** The jury listens to ALL the finalists.

**Art.4** There is no vote between each discipline

**Art.5** Each member of the jury votes successfully by secret ballot for the attribution of each of the 2 FMAJI prize, the Jean Paul NEU prize, and the designation of a substitute.

**Art.6** Each prize is awarded to the candidate who obtains the majority in the following order:

1. Special PRIZE of the DEPARTMENTAL COUNCIL of VAL-D'OISE (SALVI) ( to the candidate obtaining the greatest number of votes, all categories combined) 3050 €
2. FMAJI Daniel FAIDHERBE Award (violin) 3 000 €
3. FMAJI Daniel FAIDHERBE Award (piano) 3 000 €
4. Jean-Paul NEU prize for the best interpretation of the contemporary work imposed among all the candidates 1 000€
5. Substitute

**Art.7** For each prize awarded and in case of a tie, a second ballot will be held at the request of the President who has the casting vote.

**Art.8** The alternate laureate may perform as a soloist at concerts, upon the request of the Artistic Director and/or replace at concerts one of the two prizes due to a case of force majeure (illness, bodily injury or death)

**Art.9** The laureate who obtains the greatest number of votes, all categories combined, is automatically awarded the Special Prize of the County Council of Val d'Oise « Pierre Salvi Prize ».

**Art.10** The counting of all the ballot papers of the competition jury will be made by the President in the presence of the mayor of the city where the competition is held and who will sign the report of the results.

**Art.11** The announcement of the results is public and will be made by the President.

**Art.12** The artistic Director of the FMAJI convenes the winners at the end of the competition to prepare the concert season.

**Art.13** The candidates takes, from their admission to complete, the commitment to respect the contracts proposed to the laureates who are determining for the attribution of the Prizes, namely, among other things, to happen during all the concerts of the season and respect the conditions of the Conducteurs regarding the rehearsal services, the school activities planned by the artistic director and any other event highlighting them.

The prizes awarded to the laureates consist of a scholarship, the amount being determined each year by the Board and participation on concerts with orchestra.

The transport and accomodation of the candidates admitted to compete is not supported by the FMAJI.

In accordance with the legal provisions in force, the transportation costs of the winners during the concert season are covered exclusively under the conditions set by the administration of the FMAJI, particularly with regard to the transportation and accomodation. A maximum of 1500 euros will be devoted to that matter.

**Art.14** The result is without appeal. Any dispute of any nature whatsoever and for whatever reason will be submitted to the competent courts.
